CIRCULAR

In partial modification to this Office Circular No. E-19031/9/95/CGHS/TVM/222 Dt. 24.4.1996, the areas of No.3 CGHS Dispensary (Statue) Vanchiyoor, No.25/2893, Dharmadesam Lane, Vanchiyoor, Trivandrum 35 is re-demarcated herewith. The area covered by this dispensary will now have the following boundaries :

North West : From Mandapam Jn. To DPI Jn. To Vellayambalam Jn. Then to Museum Jn. And then to LMS Jn. To PMG Jn. Then towards west covering all left side then to Mulavana Jn. To Moolavilakam Jn. To Pattoor to Pallimukku Jn. To Pettah Jn. Covering left side of Pettah overbridge to Chackai Jn. And to proceed to NH 47 bye pass road towards Eanchackal Jn. Then to covering all left side of Vallakadavu Jn. On bye pass road.

South East: From left side of Vallakadavu Jn. To G.K. junction (Muttathara) then to Paruthikuzhy Jn. Towards Kumarichantha market Jn.(Poonthura Jn) to Thiruvallam Jn. Covering left side Parasurama Temple and to Thiruvallam Karumam Road to Madhu palam then to left side of Idagramam Karumam Road to Kaimanam Jn. Covering left side of Karamana Jn. From there to Karamana Thirumala road through Karamana Kalpalayam Road. Pareeksha Bhavan on left and Poojappura Mandapam junction.
